### **PRIVACY POLICY**

**OUR COMMITMENT TO YOUR PRIVACY.** We believe the responsible use of information is important for meeting your needs and providing consistent service quality. The more we understand about you and your needs, the better we can suggest book selections and products that are relevant to you. This privacy statement explains data collection and use practice of IJN PUBLISHING, INC., online; it does not apply to offline products or services. IJN PUBLISHING, INC., collects and maintain Personal Identifiable Information (PII) for its members, which is reasonably related to servicing member accounts: the PII we collect and maintain includes name, shipping or billing addresses, telephone number, e-mail address and, if provided (by you), credit card information (please scroll down to review our Security Protection and Safeguard Procedures in place to protect your PII).
